Resolution of the meeting of the Teachers' Council, Lala  
Rural College held on 29.11.2021 at 2.15 PM

1) A ~~to~~ threat are discussion held on academic matters of the college. Keeping in view the upcoming non C B S examination, Teachers are requested to attend the classes simultaneously along with the allotted examination duty. Adjustment of classes may be done if it is required.

2) The Principal pointed out some <sup>teachers</sup> don't attend the meetings held in the college. It is unanimously resolved that attendance in the meeting is mandatory. If any of teacher is present in the college but not present in the meeting, that will be treated as leave. But if any teacher is on leave, that case will be considered.

3) The Principal ~~appraised~~ <sup>appraised</sup> the members of the house the discussion and decision taken in the meeting of the G. B held on 06/09/2021 in regards to income tax and subsequent formation of a committee to sort out the impasse at the earliest for the greater interest of the college. The committee in its meeting referred the matter to be discussed in the TC as stake holders.

Accordingly the members took the matter very seriously and positively and considered that the employees of the college serving at that period of time from 2011 to 2016 are partly responsible as they didn't volunteered / come forward for e-filing of tax return despite repeated appeal from the DDO.

So, it would be unjust to put the blame on the respective DDOs of the period. It has also been

discussed that a large number of teachers of the said period had short deduction of different magnitude which came into notice only after the spot verification conducted by Income Tax Department in February 2018. Income Tax is a purely personal matter and after prolonged deliberations the house unanimously accorded approval to the following points and requested the Principal etc to make arrangement to realize the money from the salary of <sup>some</sup> teachers as per the following:

1) The Teachers of the period particularly those having short deductions will pay the money to the college fund as the money had already been taken away by Income Tax Department in February 2020 and February 2021.

2) Associate Professors namely Dr. Simarekha Das, Dr. Tanuj Kumar Dey, Dr. Manindra Singha and Dr. Nig. Sayamaj Singha should contribute Rs 2500/- per month from January 2022 for 24 months. As Dr. Simarekha Das HOD, Bengali retires in January 2022, she <sup>will</sup> be requested to make payment of her share towards levy fine on one or two instalments.

3) Assistant Professors Dr. L. Chiro Kumar Singha, Dr. Manas Sinha, Dr. F. U. Mazumdar, Mr. Anuradha D., Dr. Mushindra Singha, Mr. Anuradha Saha should pay Rs 1500 per month for twenty four months from January 2022.


4) Retired teachers at the period Md. Ataur Rahman

would be requested to contribute as he was an Associate Professor of that period

5) Retired DDOS of the period Mr. Ratnasekhar Bhattacharya and Tajmool Ali Hazumdar were approached and he detailed about the contributions made by <sup>some</sup> members of the Teachers' Council to this effect. This gesture will surely be appreciated by them. <sup>It is expected that</sup> they ~~would~~ will <sup>have</sup> to come forward to settle the issue for good and without further delay.

6) Mr. G. C. Banik, HOD, Commerce who was not an Income Tax Payee at that period and whose post was regularized only in August 2013 has volunteered to contribute around 30,000/- to solve the matter and the house appreciates his gesture as well as <sup>his</sup> contribution.
